3. OTHER BUSINESS/TSC STATUS UPDATE REPORT

AUGUST 2023-5, GOULD ST./KEARNEY RD. INTERSECTION, FOLLOW UP ON REDUCED LANE WIDTHS

The petitioner spoke with the daycare regarding foliage and trees the Town would like to cut. The daycare is aware and approves of geometric improvements to improve safety.

Members discussed the concept plan sketch prepared by R. Wilson for a proposed stop sign, line markings at corners with hash marks as visual indicators to be careful. He will visit the site to view curbing in place as well as radius and turn movements. Members discussed accomplishing the work before the winter.

FOLLOW-UP: Ask DPW Director Carys Lustig to notify abutters of the proposed work.

This item will be reviewed on the October agenda.

AUGUST 2023-3, WARREN ST. LINE STRIPING

Members discussed a proposed idea to test the speed before yellow lines are painted; apply the lines, then test the speed after yellow lines are applied for paved streets that have yellow lines or are planned to have yellow lines.

Members discussed resident objections to double, yellow line striping as a concern to the value of their real estate computations. The concern is off the table with reducing lane width rather than adding double, yellow lines. This would be an informed choice rather than an ask for permission.

Members discussed that reducing lane width as a traffic calming tool does not require abutter notice. When striping the road, it is best to notify abutters of the goals/objectives.

MARKED TREE ROAD

R. Wilson, engineer, has marked out 10 foot lanes between the stop signs from the railroad bridge to Central St. The road varies from 30 feet wide to 28 feet toward Central Street. Members discussed bike lanes before and at the shoulder as well as reducing the marked 10 foot lanes to 9 foot lanes.

Members discussed putting in a center line and waiting until the spring for further work. Place a speed study on this road.

Members discussed having double, yellow lines, 9 ft. travel lanes, and a speed study added to High Rock Rd. in March.
