Ms. Mulroy discussed a larger trash initiative that is being discussed with DPW, the PIO, Economic Development, and Park and Recreation. To date it has been more informal discussion to how to support trash clean up throughout Town.

Ms. Chaston discussed the Park Ranger program. Ms. Hannigan discussed engaging the Youth Sports Organizations to have a dedicated 'clean-up weekend'. Ms. Geddes stated that the dog issue at parks should also continue to be addressed. Ms. Wright suggested a potential competition between user groups.

Inform Diagnostics – Fundraising Event

Ms. Hannigan made a motion to approve the fundraising event to be held by Inform Diagnostics for a fee of \$500. Mr. Gerstel seconded the motion and it passed 5-0.

John Eliot PTC - Kindergarten Event

Mr. Gerstel made a motion to approve the kindergarten event to be held by John Eliot PTC at Eliot and waived the special event fee. Ms. Geddes seconded the motion and it passed 5-0.

Needham Track Club – Youth Track and Field Event

Ms. Hannigan made a motion to approve the special event requests by Needham Track Club with a fee of \$500 for the event. Mr. Gerstel seconded the motion and it passed 4-0-1.

Coach O's Soccer TEAMS LLC - Camp

Mr. Gerstel made a motion to deny the special event request from Coach O's Soccer TEAMS LLC for the requested two-week camp. Mr. Williams seconded the motion and it passed 5-0.

Broadmeadow PTC - Kindergarten Events

Mr. Gerstel made a motion to approve the requests from Broadmeadow PTC to host two events to support the upcoming Kindergarten Class. Ms. Hannigan seconded the motion and it passed 5-0.

Charles River Center – Track and Field Event

Mr. Gerstel made a motion to approve the special event request and a \$200 fee. Mr. Williams seconded the motion and it passed 4-0-1. Ms. Mulroy stated that she will talk to the Parks & Forestry Superintendent about the upcoming track project.
