Needham Student Council – Thanksgiving Bonfire and Pep Rally

Ms. Hannigan made a motion to approve the Thanksgiving Bonfire event to be held by Needham High School Student Council in the Upper NHS Parking Lots on Tuesday, November 23 from 4:30pm – 8:30pm. The fee for this event has been waived. Ms. Geddes seconded the motion and it passed 5-0.

St. Joes – Recess Field Use

Mr. Gerstel made a motion to approve the use of Greene's field for limited outdoor recess to be held by St. Joe's on various afternoons in November. The fee for this event is \$200. Ms. Hannigan seconded the motion and it passed 5-0.

Needham Farmer Market – Use of Greene's Field pathways near Great Plain for 2022 season

Ms. Hannigan made a motion to approve the use of Greene's field pathways along Great Plain Avenue during the 2022 season throughout the construction of the Town Common for the Farmers Market. There will be no additional fee charged outside of the annual fee charged in past years. Mr. Gerstel seconded the motion and it passed 5-0.
